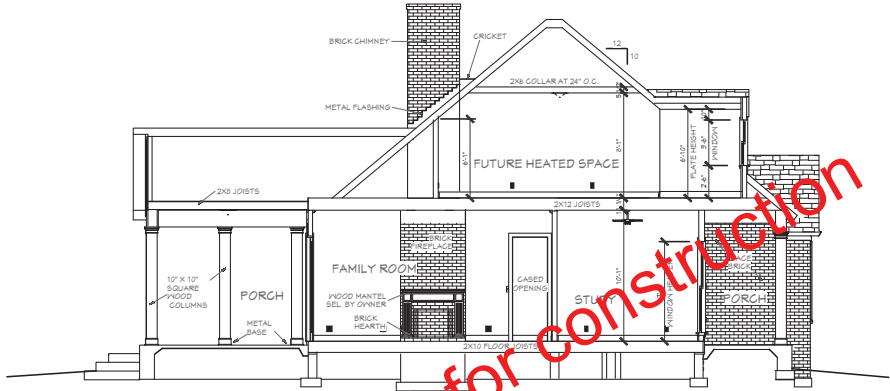

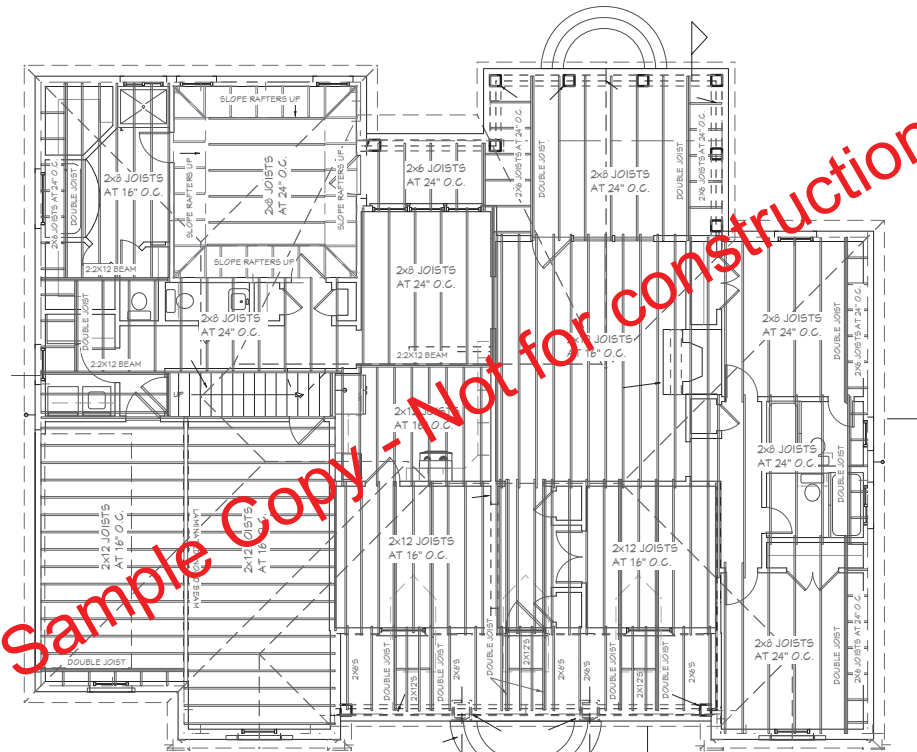


BUILDING CROSS SECTION B-B

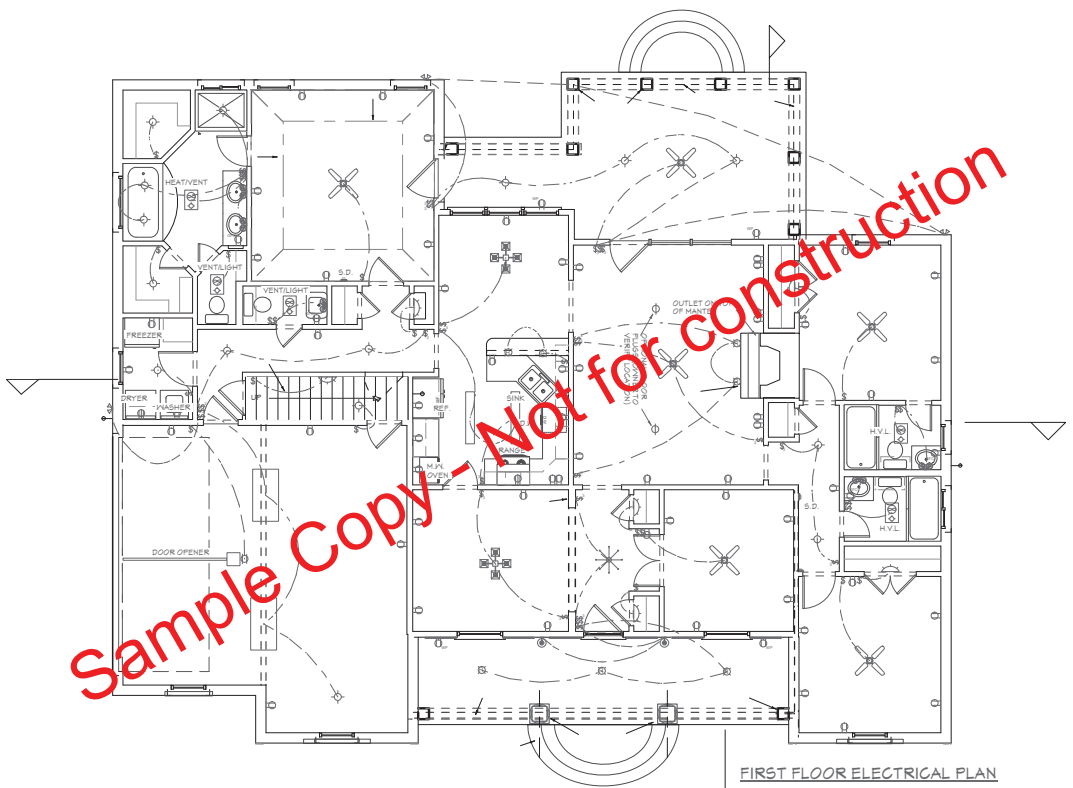
FIRST FLOOR CEILING FRAMING PLAN
